1.	The total number of section of the school shall be restricted to 13 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 5 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

<b>Sl. No.</b>	<b>CONDITIONS FOR COMPLIANCE</b>
1	1. The total number of sections of the school shall be restricted to 13 and further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2	2. The school shall conduct training of its teachers with CoE Prayagraj within 3 months and submit the compliance.
3	3. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
4	4. The school has converted normal cubicles in the wash rooms as CWSN toilets. But they are too small and narrow for a wheel chair/walker to navigate. The ramp constructed by the school is too steep for CWSN to navigate ion their own. The school shall make provision for separate toilets for CWSN, boys and girls on every floor and construct /modify the existing ramp as per norms of RPwD Act and guidelines issued by the Board or install a lift and submit compliance within 3 months on SARAS portal.

5	5. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time
